2. These vessels are of Singapore origin. CAT III A vessels are of 9M long fitted with two 250 HP Mercury mariner OB engines and CAT III B vessels are of 6M long fitted with two 115 HP Mercury mariner outboard engines. The vessels are equipped with GPS, radar, Satellite communication system and VHF/UHF System onboard.

3. Engine maintenance routines of 100 hourly and 250 hourly needs to be done with replacement of spares. Service providers must be having **access to genuine spares for engines along with the licence** for defect rectification and routine maintenance as well. Vessels need to be hauled up in cradles for underwater hull cleaning and painting with anti-fouling paint as six monthly routine depending on condition.
