Applications are invited from aspiring advocates, who qualify in terms of Section 24(8) of the Criminal Procedure Code, 1973 to the Bar Council of the High Court/Bar Associations of Subordinate Courts to appear on behalf of the department in the subordinate courts/Court of Sessions / Before the Madurai Bench of the Hon'ble High Court Madras for Tiruchirapalli Customs Commissionerate. 2. The person should presently be in practice as an advocate with sufficient knowledge of Customs Act, 1962 and relevant Acts. The first engagement of an SPP shall normally be for a period of 18 months.

3. Eligible persons may submit their application along with Bio-data, willingness and copies of relevant documents to this office on or before 20.07.2016. "Application for the post of Special Public Prosecutor" should be written on the envelope.
