- 2. Separate sealed tenders should be submitted as in the annexure to the notice quoting the price for the above said goods. The tender price should be read exclusive of all taxes, Central or State wherever applicable.
- 3. The Earnest Money Deposit (EMD) of Rs.10,000/-(Rupees ten thousand only) for each item in the form of Demand Draft drawn in favour of Assistant Commissioner of Customs, Customs Division, Tuiticorin shall be sent along with the sealed tenders.
- 4. The sealed tenders should be addressed to the Assistant Commissioner of Customs, Customs Division, Tuticorin 628 001 and will be received at the Office of the Assistant Commissioner of Customs, No.66, Beach Road, Tuticorin -1, up to 17:30 hrs on 17.12.2013 and the same will be opened in the presence of the tenders at 11:30 hrs on 18.12.2013. Tenders which contain any correction or over-written or any addition or deletion are liable for rejection.
- 5. If the tender price is not acceptable, open auction only among the tenders will be conducted at 15:00 hrs on the same day.
- 6. The goods may be inspected by the prospective Bidder at this Office, during normal office hours prior to the date of auction.

- 7. Only the highest bid will be accepted and the successful tenders/bidders shall be required to pay 25% of the tender value by cash on the spot on acceptance of the tender by the Assistant Commissioner including provisional acceptance. The balance amount with appropriate Sales Tax/VAT and Surcharge etc. if any, has to be paid within seven days of auction or intimation of final acceptance in case of provisional acceptance, failing which the 25% advance amount already collected will be forfeited to the Government of India without any intimation to the successful tenders/bidders. Apart from the sale value all purchase, sale and other Central, State and Local taxes if any, that may be levied, shall be payable by the successful tenders/bidders.
- 8. The goods shall remain in the custody of the Department in every respect at the risk of the bidder from the date of acceptance, including provisional acceptance of the bid and the Government shall not be under any liability for the safe custody or the preservation thereof from the date of acceptance including provisional acceptance.
- 9. When the purchaser is not taken the delivery of the goods for any unforeseen reasons after acceptance of bid he shall not be entitled to make any claim for damage, loss or profit or compensation on any account.
- 10. Whenever any claim for payment of a sum of money to the Government shall without prejudice to any other remedy, be entitled to deduct such sum of money from any sum due or which at any time thereafter may become due to the buyer under any contract with the Government and if this is not sufficient to cover the full amount recoverable, the buyer shall pay to the Government on demand the balance due.
- 11. All disputes and differences arising out of or in any way touching or concerning the agreement for sale whatsoever shall be referred to the sole arbitration of the Commissioner of Customs, No.1 William Road, Tiruchirappalli or any person nominated by him. It will be no objection that the arbitrator is a Government servant that he has to deal with all or any of the matters in dispute of difference. The award of such arbitrator shall be final and binding on parties to the agreement.
- 12. The Department reserves the right to reject any or all tenders/bids without assigning any reasons there for. The Department also reserves the right to withdraw the above said goods from the tender/Auction without assigning any reasons there for. The decision of the Assistant Commissioner is final in this regard.
- 13. Sale of above said goods is purely on 'AS IS WHERE IS BASIS' condition. The goods shall be taken from the site with all faults and errors in description or otherwise, quantity, size, measurements, number, weight as stated in the list or approximate and no warrantee or guarantee shall be implied. The above said goods are sold on the assumption that the bidders have inspected the above said goods and know that what they are buying. The principle of CAVEAT EMPTOR will apply and no complaint will be entertained after sales.
